    - Maintain one platform for students-Edmodo
    - Create a unified grading system across the grade levels
- Quarter 3 Awards assembly will be by individual homerooms
- School leadership committees seeking parent representatives for K-2 and 3-5
- Completed the Technology plan for the school-posted on the school's website
