- Changes include teacher attendance, updating the verbiage "teacher" to "employee" throughout, removing global app as this
 was completed, and adding integrating to curriculum.

Head of School Report David Kukielski

- Admissions database is approx. 900 (899 enrolled and 4 in process of registering).
- Capital campaign update as follows.
 - o Requesting \$1.8M for the renovation.
 - o Reviewing marketing materials and potential kickoff event.
 - Donation forms have already been given to employees and goal to rollout by end of November prior to "Giving Tuesday"
 - Students are interested in having their own development committee to help.

Principal's Report

- The "I Will" wall is showing over 300 students who received the honor roll. They were celebrated with a cookie reception.
- The 9th grade had an overnight field trip to Virginia.
- Many student accomplishments to boast.
 - 4 students were selected to attend the NCHSAA student conference.
 - o 1 student selected by the Charlotte Observer as a "player to watch" for basketball.
 - All students on the roster for the winter sports are eligible academically to play for NCHSSA.
- Completed two assessments: pre-ACT and NCDPI 5th grade math fidelity check (to determine progression of common core).
- For professional growth, completed data analysis for Teacher Working Conditions Survey.
- · Reviewed discipline data, a lot of the day is spent on discipline with highest concentration involved for middle school students.
- The Duke Energy My Energy Kit challenge is underway. Additional messaging and presentations are coming.
